Other Information:

The total number of shares resulting from the Company's share buyback program conducted during the 2021 2022 period amounted to 250,158,300 shares, of which 165,628,900 shares have been transferred. The Extraordinary General Meeting of Shareholders of the Company held on 21 May 2026 approved the withdrawal of a portion of the shares acquired through the Company's share buyback program carried out during a period of significantly fluctuating market conditions from 6 December 2021 to 6 December 2022, totaling 84,529,400 (eighty-four million five hundred twenty-nine thousand four hundred) shares, each having a nominal value of Rp500 (five hundred Rupiah), as a reduction of the Company's issued and paid-up capital. As of the date of this report, the Company is still within the 60-day creditor objection period as stipulated under the Indonesian Company Law, which is expected to end on 22 July 2026. Upon completion of this period, the process will proceed with the issuance of a Decree of the Minister of Law of the Republic of Indonesia. The Company will undertake all required procedures for the withdrawal of such shares in accordance with the prevailing laws and regulations. The total number of shares resulting from the Company's share buyback program conducted during the period from 15 May to 31 December 2024 amounted to 81,099,500 shares, none of which have been transferred. The total number of shares resulting from the Company's share buyback program conducted during the period from 22 May 2025 to 21 May 2026 amounted to 66,249,700 shares, none of which have been transferred.
