

# IndoCement Celebrates 50 Years of Contribution to the Nation: Forever Strong and Trusted

On August 4, 2025, PT IndoCement Tunggal Prakarsa Tbk. (IndoCement) celebrated its 50th anniversary by hosting a grand Gala Dinner at The St. Regis Jakarta. The event was attended by Mr. Tedy Djuhar representing the family of Mr. Djuhar Sutanto, Mr. Axton Salim representing the family of Mr. Soedono Salim, Mrs. Miana Sudwikatmono representing the family of Mr. Sudwikatmono, and Mrs. Dina Rijstad representing the family of Mr. Ibrahim Risjad, along with invited guests including IndoCement's key distributors, contractors, and vendors.

In his remarks, IndoCement President Director Christian Kartawijaya expressed deep appreciation to all stakeholders who have been part of the company's long journey since its establishment in 1975.

"Fifty years is more than just a number—it symbolizes the dedication, innovation, and collaboration that have shaped IndoCement into a leader in the national cement industry," said Christian Kartawijaya.

## Legacy and Transformation Toward a Sustainable Future

Founded by visionary leaders known as the Gang of Four—Mr. Soedono Salim, Mr. Djuhar Sutanto, Mr. Sudwikatmono, and Mr. Ibrahim Risjad—IndoCement began its operations with a single plant in Citeureup, West Java. Today, IndoCement operates sixteen cement plants across five factory complexes and one grinding mill, with an annual cement production capacity of 33.5 million tons and a nationwide distribution network.

Aligned with IndoCement's New Purpose, *Materials to Build Our Future*, the company continues to innovate by introducing environmentally friendly products. IndoCement has successfully reduced carbon emissions to 520 kg CO<sub>2</sub> per ton of cement using alternative fuels such as refuse-derived fuel (RDF) and biomass, alternative clinker substitutes like slag and fly ash, and the installation of rooftop and ground-mounted solar panels at its factory complexes.

IndoCement is also a pioneer in developing and marketing green cement, offering various types such as Portland Composite Cement (PCC), Portland Pozzolan Cement (PPC), slag cement, and hydraulic cement. Additionally, IndoCement has introduced derivative products such as mortar and remains the only producer of white cement in Indonesia. The company has expanded its product portfolio under five main brands: Semen Tiga Roda, Semen Rajawali, Semen Grobogan, Semen Bosowa, and Semen Jempolan.

"IndoCement continues to broaden its reach through business expansion, adding new plants and cement terminals, and strengthening its logistics fleet, including vessels, to make our products more accessible to communities," added Christian Kartawijaya.

## 50<sup>th</sup> Anniversary Celebration: Sharing Joy, Creating Meaning

To mark its 50<sup>th</sup> anniversary, IndoCement organized 50 activities throughout 2025 involving its stakeholders. One highlight was the *IndoCement Family Fun Picnic* at Taman Mini Indonesia Indah (TMII) on August 2, 2025, attended by more than 5,000 participants.

On this occasion, IndoCement set a MURI record for the "Batik on Cement Sack" activity with 5,000 participants and launched a special edition 50th anniversary cement bag. IndoCement also invited 50 artists from five art communities to paint on cement bags, which were later used as fundraising media for building and renovating uninhabitable houses for construction workers in various regions.

**Mengenai Indocement**

Indocement adalah salah satu produsen semen terbesar di Indonesia yang memproduksi Semen Tiga Roda, Semen Rajawali, Mortar Tiga Roda, dan Semen Grobogan. Saat ini Indocement dan entitas anaknya bergerak dalam beberapa bidang usaha yang meliputi pabrikasi dan penjualan semen (sebagai usaha inti) dan beton siap-pakai, serta tambang agregat dan trass, dengan jumlah karyawan sekitar 3.700 orang. Indocement mengoperasikan 14 pabrik milik sendiri serta dua pabrik dan satu grinding mill dengan sistem sewa dengan total kapasitas produksi tahunan sebesar 33,5 juta ton semen. Sepuluh pabrik berlokasi di Kompleks Pabrik Citeureup, Bogor, Jawa Barat; dua pabrik di Kompleks Pabrik Cirebon, Cirebon, Jawa Barat; dan satu pabrik di Kompleks Pabrik Tarjun, Kotabaru, Kalimantan Selatan; satu pabrik di Grobogan, Jawa Tengah; dua pabrik di Maros, Sulawesi Selatan, dan satu grinding mill di Banyuwangi, Jawa Timur. Pada 2022, Indocement telah mengoperasikan Pabrik Maros setelah menandatangani Perjanjian Sewa Pakai Aset dengan PT Semen Bosowa Maros dan PT Bosowa Corporindo. Heidelberg Materials AG telah menjadi pemegang saham mayoritas Indocement sejak 2001.
